Conflict minerals

Dear Sir or Madam

At the moment we are getting many inquiries regarding the use of conflict materials respectively the Dodd-Frank-Act.

We like to inform you by this letter that we purchase exclusively components from renowned producers and distributors. Unfortunately we have no influence on the origin of the minerals used by our suppliers. So in this respect we can not take any responsibility.

However, for all products of our suppliers we request transparency and traceability. On their websites many producers give information about the nature of their materials as well as their origin. We have asked our suppliers to send us corresponding information and as far as we know at present no one of our suppliers is using conflict material originating from the Democratic Republic of Congo or one of the countries Angola, Burundi, Rwanda, Zambia, Sudan, Tanzania, Uganda and Central African Republic. In addition, in our purchase orders we request compliance with the Conflict Minerals Regulation.

Our company does not import any minerals directly and this includes of course any so-called conflict minerals like cassiterite (tinstone), columbite-tantalite (Coltran, tantalum), gold or tungsten (wolframite).

Please understand that with regard to the increasing number of inquiries we are not in a position to complete particular questionnaires. So we hope that the present letter gives you the requested information and thank you for your confidence and good cooperation.
